

In consideration of the terms and conditions set forth herein, \_\_\_\_\_ (customer) and Golf Car Services, Inc. (vendor) hereby agree as follows:

Vendor leases each car to customer in 'as is', 'with all faults' condition, without any warranty or representation, either expressed or implied, as to the fitness of the cars for any particular purpose. Customer assumes all responsibilities for and all risk of loss, damage or injury, including death that may occur to the undersigned in connection with the use of any golf car.

Customer hereby releases vendor, its owners, officers, agents and employees, and shall indemnify, and save vendor, its owners, officers, agents and employees harmless from any liability, loss, damage, expense, cause of actions, attorney's fees, suits, claims, or judgments. Whether in law or equity in rising from any injury to a person resulting from or based on the actual alleged use, operation, delivery or transportation of any and all cars described below whether based in tort, contract, strict products liability or based on its location or condition, and shall, at customer's own cost and expense defend any and all suits which may be brought against the vendor, its owners, officers, agents and employees, either alone or in conjunction with others, upon said liability and claims. Customer will provide his own insurance to cover any said liability claims by any person or persons, operators, or passengers in any amount against such action or actions. In any event, vendor will not be liable for any damage, whether direct, incidental and special or inconsequential in excess of the leasing fee by customer, whether or not vendor had knowledge that such damages might be incurred, including but not limited to, loss of income or profits.

Customer is responsible for and agrees to pay for any and all damages to or the theft of cars on a "cash on demand" basis on the value of the car(s) up to \$3500 per car. Customer shall report theft, accidents, to the car immediately by calling (904) 213-9000. Customer will pay for any said damages to or theft of the car(s) leased under this agreement by the credit card used to hold for security deposit. \_\_\_\_\_ (customer initials here)

Customer acknowledges that he/she has had the opportunity to check the car and it is in the same condition as it will be returned. Once the car leaves possession of the vendor then customer assumes the entire risk of loss, theft and destruction or damage to the car from any cause whatsoever. \_\_\_\_\_ (customer initials here)

In the event of any legal action, including arbitration proceedings, seeking enforcement of this agreement, vendor shall be entitled to recover reasonable attorney's fees and the cost of such proceedings.

- Customer may not assign its right under this agreement.
- All drivers must be of legal driving age and possess a valid driver's license.
- DO NOT tamper with the speed of the golf car. NO EXCEPTIONS!! Serious death or injury may occur, as well as damage to the car.
- Remove key and secure car when it is not in use.
- The car can only be used for what it is designed for - ie: 4 passenger car carries 4 people
- You must return the car in the same condition you receive it.
- If you return the car later than your rental agreement, you will be charged a \$25 per day late return fee.
- If the car is not returned to our shop after the event you will be charged a \$100 pick-up fee

Failure to comply with these lease conditions will be cause for forfeiture of this car and any deposits or payments made. You MUST present a credit card for security deposit, regardless of payment type.

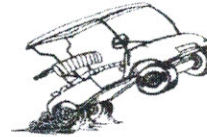
